**A RECORDING FEE** of \$3.00 will be required for each dog entered at any AKC licensed or member club show, obedience or rally trial. This recording fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 11, Section 2).

**TELEPHONE AND UNSIGNED ENTRIES** cannot be accepted.
