## PARTICIPATION AGREEMENT

This Fun Day/Practice is open only to purebred Portuguese Water Dogs. The dogs must be in good health and proper fitness and condition for the class that they are registering for.

I/we have received and read the "Club Safety Rules" and above statement of conditions as provided for water training by the Nutmeg Portuguese Water Dog Club, Inc. I/we agree and consent to obey and abide by all the rules and policies therein.

I/we agree that the Nutmeg Portuguese Water Dog Club, Inc. has the right to refuse this entry or any entry for any cause(s) which it deems sufficient.

I/we accept full responsibility for the care of my/our dog(s) before, during and after, the water classes.

I/we agree to hold the above-listed [clubs and organizations], [their] [its] members, directors, governors, officers, agents, judges, instructors, volunteer organizations, individual helpers, superintendents and/or show secretary(ies), the owner or lessor of the premises and/or any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of my/our dog(s) while in or upon the **Camp Pomperaug**, premises or grounds or near any entrance thereto; and I/we personally assume all responsibility and liability for any such claims.

I/we agree to hold the aforementioned parties harmless from any claim for loss of my/our dog(s) by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog(s), whether such loss, disappearance, theft, damage, or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I/we hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself/ourselves, or on account of damage to property, arising out of or in consequence of my/our participation in this water class, however such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

I/we further agree to arbitrate any question of whether any such claim is subject to such arbitration. I/we agree that any such arbitration shall take place at an agreed upon site in the greater Stamford, Connecticut area within 45 days of the incident giving rise to the claim, or at such other place and time as the arbitrators shall agree. I/we agree that I/we will pay a pro-rated share of the costs of any such arbitration.

I/we further agree to arbitrate any question of whether any such claim is subject to such arbitration. I/we agree that any such arbitration shall take place at an agreed upon site in the greater Stamford, Connecticut area within 45 days of the incident giving rise to the claim, or at such other place and time as the arbitrators shall agree. I/we agree that I/we will pay a pro-rated share of the costs of any such arbitration.
