The applicant's name(s) and the sponsors' recommendations shall be read at that meeting. The applicants' name(s) shall be included in the notice for the next meeting with the notice that the application shall be submitted for a vote by secret ballot of the Voting Members in good standing present and voting at that meeting. Membership shall be accepted by affirmative votes from not less than two-thirds (2/3) of the members present and voting by secret ballot. The Board of Directors, Membership Committee or any member in good standing can make recommendations on every application.
